Minutes of the Meeting of Gunness Parish Council, held on Thursday 18th September 2025 at 7:00pm, at Gunness Village Hall, Gunness, Scunthorpe.

01.09.2025 - Apologies for absence

Apologies for absence were received from Cllr L Walker (dispensation), Cllr S Armitage, Cllr S Priest, Cllr D Medley, Cllr D Hart, Cllr D West, Cllr B Etchell & NLC Ward Cllr J Walshe.

Cllr T Gosling advised Cllr S Armitage has requested dispensation due to illness.

Resolution - The Parish Council agreed to grant Cllr S Armitage dispensation for 1 year. The Parish Council also approved for flowers to be sent to Cllr S Armitage.

03.09.2025a - Minutes - To approve the Minutes of the Meeting held on 10th July, 2025

03.09.2025b - Questions & Updates from the minutes

Cllr G Berridge-Burley expressed concerns over the village grass cutting. Clerk and Cllr T Gosling explained the Contractor carries out the work to the required standard as per NLC guidelines.

07.09.2025 - Planning Matters

PA/2025/1087 - Consultation consent to display an advertisement at Street Record, M181 from M180 to A1077, Burringham, DN17 1US - **Resolution - The Parish Council considered this application and no concerns were raised.**

PA/2025/1036 - Consultation householder planning permission at the Bungalow, Rear of 16 Station Road, Gunness, DN15 8TH - **Resolution - The Parish Council considered this application and no concerns were raised.**

08.09.2025 - Matters relating to Lodge Moor Estate

Cllr P McIlvaney advised the grass has now been cut near to M&S; however they are concerns over fly tipping and the Estate in general being untidy. Cllr P McIlvaney has reported to NLC Ward Cllr J Walshe.

09.09.2025 - Matters relating to Hilton Avenue Estate

Cllr L Gosling advised weeds need clearing along the kerbs and gutters, which requires a road sweeper.

10.09.2025 - Playing Field Matters

- Letter from Natural England requesting permission to access land for the England Ecosystem Survey - **Resolution - The Parish Council agreed for the Clerk to respond giving permission.**

- Email request regarding car park white lines - **Resolution - The Parish Council agreed not to consider whilst there are abandoned cars in the car park. Clerk to report the 2 cars to the local police team for action.**

- Email regarding request from men's football team - **Resolution - Cllr T Gosling advised a request was received from the former team manager which was declined as previously agreed the pitch was at capacity. Noted.**

11.09.2025 - Correspondence

- Ernlca Local Government Reorganisation survey - Circulated and Councillors to respond individually if required - Noted.
- Annual Police Survey 2025 - Circulated and Councillors to respond individually if required - Noted.
- To consider a SSE Grant Project application - **Resolution - The Parish Council agreed for the Clerk to submit an application for the garden corner near the pensioner's bungalows for this to be tidied up and landscaped. Clerk to obtain 3 quotations and Cllr E Gray to meet Contractors. Clerk to request permission from Ongo as it is on their land.**
- To consider alternative provision for the cleaning of the bus shelters - Clerk advised the current Contractor cannot continue. **Resolution - The Parish Council agreed for the Clerk to obtain prices for a window cleaner to carry out the cleaning of the bus shelters in Gunness and Lodge Moor.**
- To decide on Wreath laying and requirements for Remembrance Day - **Resolution - The Parish Council agreed for Cllr B Etchell to lay the wreath on the Parish Councils behalf. Clerk to order a wreath direct to Cllr B Etchell.**
- Email from HALMA re PCC Grant - Cllr D Whiteley explained the PCC will be writing to the Parish Council to request the deposit of £406. **Resolution - The Parish Council agreed once the invoice is received for the Clerk to pay.**

12.09.2025 - NATS Issues/Updates

Cllr G Berridge-Burley attended the latest meeting.

13.09.2025 - Any update on the Parish Council Website & GDPR

The Parish Council are monitoring for updates.

14.09.2025 - Councillors Reports

Cllr D Whiteley advised the Parish Council donation of £500 has been retained by the Clerk at his request whilst the group are trying to recruit new members. Cllr T Gosling suggested that the group think of a suggestion for a scheme to spend the £500 on and to advise the Parish Council accordingly.

Cllr G Berridge-Burley reported the street lighting is of a poor quality in Gunness.

Cllr G Berridge-Burley reported flooding has been an issue in Beech Avenue in Gunness.

Cllr G Berridge-Burley expressed concerns that residents are still crossing the motorway by foot due to the lack of signage. All 3 issues Cllr G Berridge-Burley has reported directly to NLC Ward Cllr J Walshe.

Cllr T Gosling reported on behalf of Cllr S Priest concerns over the lack of a zebra crossing for the older school children to use along the A18 Station Road. **Resolution – The Parish Council agreed for the Clerk to contact NLC Highways to see if this can be considered.**

Cllr T Gosling reported on behalf of Cllr S Priest concerns over fly tipping in general in the area and flags and graffiti on Keadby Bridge – Cllr S Priest to report directly to NLC Ward Cllr J Walshe.
